#### **Sad News**

It is with deep regret we announce the passing of our longtime friend and club member, Pat Azarnoff on March 16, 2017.

Pat and her Husband Roy were long time members of the Pass Democratic Club. They served on the Executive Board and it was due to their efforts that the club could set-up and maintain our 2008 office. Pat organized the entire office and established the schedule for all volunteers. She was the recipient of the 2008 Pass Democratic Club Volunteer of the Year Award. Pat held a Master's Degree in Child Development and special education from Boston University and was an Author. Pat also was the Founding Director of Pediatric Projects a non-profit corporation that developed special toys and equipment for hospitalized children.

Roy died August 25, 2012. He held a PHD from the University of Missouri. He was the Director of the Los Angeles Area Agency on Aging, director of the Western Center for Clinical Studies and a Professor at Boston University and an Author. He also set-up the Pass Democratic Club original website, our entire computer system and was a member of the Riverside County Democratic Central Committee.

It was our honor and pleasure to work with both of these outstanding people and we miss them. But they have left behind an enormous legacy of good works and we honor their memory.


#### TRUMP'S TAX PLAN PROPOSAL RESULTS (Business Insider)














A quick synopsis of some of the main changes that would affect taxpayers. Instead of seven, we'd have three income tax brackets. Current: 10%, 15%, 25%, 28%, 33%, 35%, 39.6%. Proposed: 12%, 25%, 33%/ The standard deduction would go way up. It jumps from \$6,300 to \$15,000 for singles; for married joint filers, it jumps from \$12,600 to \$30,000. Personal exemptions and exemptions for dependents would be eliminated, as would the head-of-household deduction. Families with children under age 13 could deduct childcare costs, capped at the state average. The alternative minimum tax, a complicated surtax that raises rates on middle- to upper-middle-class earners, would be axed. It currently affects nearly 5 million people. Gift taxes and estate taxes would be gone; capital gains held until death would be exempt up to \$5 million per person.

California passed a 10 year \$52 billion roads and infrastructure bill (SB 1) this month raising gas taxes and registration fees by an average of \$10 per month per family. The five year \$100 billion list of 51 priority projects includes roads, levees, bridges, ports, train and public transit systems, water storage and recycling projects, and energy, military, veterans and emergency operations facilities and services. #### May Day Rallies and Protests Planned Throughout Southern California

Thousands of workers, immigrant-rights activists and other protesters will take part in May Day marches and rallies May 1 in support of causes ranging from better-paying jobs to immigration reform, triggering street closures in downtown Los Angeles.

Rallies are planned throughout the day at various locations, including one at Los Angeles International Airport in connection with a one-day strike by janitors and other workers at the facility, but downtown will be the main rallying point for protests by such groups as Occupy L.A., the Youth Justice Coalition and Rise Up L.A. Occupy L.A. planned a "May 1 Four Winds/General Strike" event involving four "caravans" converging on downtown L.A. The South Wind caravan will start at Cal State Dominguez Hills in Carson, the West Wind at Wilshire Boulevard and Ocean Avenue in Santa Monica, the North Wind at Panorama High School in the San Fernando Valley, and the East Wind at Cesar Chavez and Atlantic Avenue in Monterey Park.

Around noon, protesters will gather at 41st Street and Central Avenue, then head to Figueroa Street and Exposition Boulevard before staging a 2:30 p.m. rally at Sixth and Main streets. A larger rally is planned at 7 p.m. at Pershing Square.

Supporters of the Coalition for Humane Immigrant Rights of Los Angeles will take part in a May Day march for jobs, education and "peace in the world," with participants gathering at Olympic and Broadway at 1 p.m. and marching an hour later north on Broadway. A rally is planned for 3:30 p.m. at Broadway and First Street.

Local rallies are planned in Redlands, Riverside, Anaheim, Santa Ana and possibly other cities as the date draws closer. Some or all may be posted on www.may1.org


