Postage for ballots will now be paid for by the state. Banning Council member, Colleen Wallace McFrazier, has been recognized by various organizations for her valuable contributions and efforts in support of women.

1st Vice President, Kathy Katz: Kathy reminded us to use the microphones to speak in the meeting. Kathy reported 141 members. Pelton inquired on how to get names/numbers and Howard will follow up with LeeAnn.

2nd Vice President, Sylvia Carrillo: Sylvia acknowledged Colleen Wallace McFrazier being honored as a Rising Star by Women of the Desert.
