President Donald Trump's campaign manager is quietly channeling money to Eric Trump's wife, Lara Trump, and Donald Trump Jr.'s girlfriend, Kimberly Guilfoyle, The New York Times reported Monday.

The payments are hidden from public view because they're made through campaign manager Brad Parscale's private company, Parscale Strategy, based in San Antonio, sources told the Times. Typically, such payments would be part of public filings required by the Federal Election Commission so that donors can find out how their contributions are being used — in this case, to pay members of the president's family.

The family benefits are linked to a network of politically connected private companies — operating with the support and help of Trump son-in-law Jared Kushner — that have charged roughly \$75 million since 2017 to the Trump reelection campaign, the Republican National Committee and other Republican clients, according to the Times.

Guilfoyle last year angrily confronted Parscale about late checks owed to her, two witnesses told the Times. He reportedly promised that the situation would be rectified by his wife, Candice Parscale, who often handles his company accounts. One of Lara Trump's most notorious contributions to her father-in-law's campaign early this year was to mock rival Joe Biden's stutter, which he has grappled with since he was a child.

She was initially hired as a senior consultant in early 2017 by another Parscale company, digital vendor Giles-Parscale, also based in San Antonio, The Associated Press reported. Lara Trump was to serve as a liaison between the company and Donald Trump's campaign, headquartered in Manhattan's Trump Tower, which is owned by the president's Trump Organization. Parscale was named Trump's reelection campaign manager the following year.

The Trump campaign announced in January that Guilfoyle, a former Fox News personality who started dating Trump Jr. two years ago, would lead the joint fundraising drive between the campaign and the RNC.

Guilfoyle left Fox News in 2018 following a human resources investigation into allegations of inappropriate behavior, including sexual misconduct, HuffPost reported at the time. An attorney for Guilfoyle denied all accusations as "unequivocally baseless." HuffPost could not immediately reach Parscale for comment.

Parscale declined to comment to the Times "in detail" on the article, the paper reported. He has, however, said in the past that private companies provide greater flexibility in a campaign, given campaign finance law requirements.

## Socialism 101

**DEMOCRATIC SOCIALISM:** The government mostly benefits citizens. Major industries can be privately owned (Capitalism) but do not receive handouts from the government at the taxpayers' expense. The tax burden is shared equitably, with wealthy corporations and individuals paying their fair share to help fund public services like education, healthcare, police, firefighters, roads, libraries, etc. With this system, middle class thrives and poverty decreases. This system most closely aligns with Democracy = rule by the people.

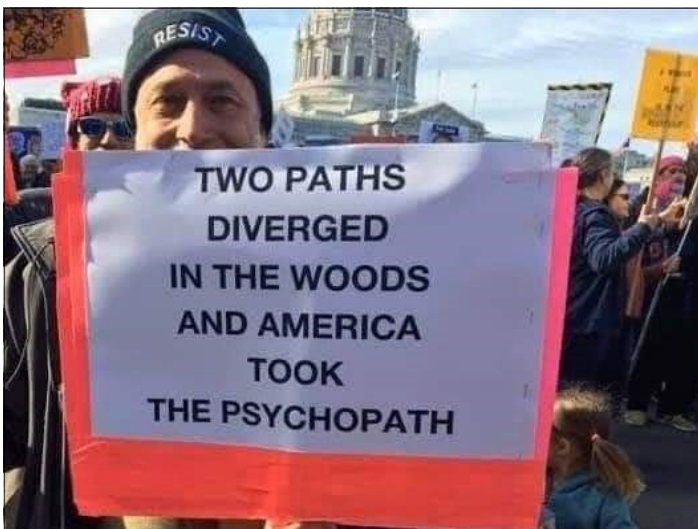

Example: A journalist tweeted something that annoyed Donald Trump Jr., prompting the coterie of friends and allies surrounding the president's son to drum up a hit piece, part of a coordinated effort by a coalition of Trump allies to air embarrassing information about reporters who produce critical coverage of the president.

Parscale, Trump's campaign manager, has said the campaign intends to train "swarms of surrogates" to under-

mine coverage from local TV stations and newspapers. Polls have long found that Americans across the political spectrum trust local news more than national media. If the campaign has its way, that trust will be eroded by November. Running parallel to this effort, some conservatives have been experimenting with a scheme to exploit the credibility of local journalism. Over the past few years, hundreds of websites with innocuous-sounding names like *the Arizona Monitor* and *The Kalamazoo Times* have begun popping up. At first glance, they look like regular publications, complete with community notices and coverage of schools. But look closer and you'll find that there are often no mastheads, few if any by-lines, and no addresses for local offices. Many of them are organs of Republican lobbying groups; others belong to a mysterious company called Locality Labs, which is run by a conservative activist in Illinois. Readers are given no indication that these sites have political agendas—which is precisely what makes them valuable.

Instead of trying to reform the press, or critique its coverage, today's most influential conservatives want to destroy the mainstream media altogether. "Journalistic integrity is dead, there is no such thing anymore. So everything is about weaponization of information."

It doesn't require an overactive imagination to envision a worst-case scenario: On Election Day, anonymous text messages direct voters to the wrong polling locations, or maybe even circulate rumors of security threats. Deepfakes of the Democratic nominee using racial slurs crop up faster than social-media platforms can remove them. As news outlets scramble to correct the inaccuracies, hordes of Twitter bots respond by smearing and threatening reporters. Meanwhile, the Trump campaign has spent the final days of the race pumping out Facebook ads at such a high rate that no one can keep track of what they're injecting into the bloodstream.

After the first round of exit polls is released, a mysteriously sourced video surfaces purporting to show undocumented immigrants at the ballot box. Trump begins retweeting rumors of voter fraud and suggests that Immigration and Customs Enforcement officers should be dispatched to polling stations. ARE ILLEGALS STEALING THE ELECTION? reads the Fox News chyron. ARE RUSSIANS BEHIND FALSE VIDEOS? demands MSNBC.

The votes haven't even been counted yet, and much of the country is ready to throw out the result. The election's legacy will be clear—not a choice between parties or candidates or policy platforms, but a referendum on reality itself.
